#### Affected by the Floods?

While Queensland has borne the brunt of the Nation's attention during the wet season, many families & businesses in Victoria have also suffered damage. If you feel that you have been directly or indirectly affected by this natural disaster, we have some information which shows what assistance and consideration can be offered by the State Government, banks, insurance companies and the ATO. #### **Personal Insurance assessments**

In August last year we advertised our external insurance advisor, Laurence McCarthy who was prepared to visit our clients on site and review their life insurance needs. About 15 of our clients took up the offer and nearly all of them discovered that they were paying too much for their current premiums. ### When can I throw my old tax files out?

The ATO requires all documentation must generally be kept for a period of five years for audit purposes. The exceptions are for depreciation and capital gains issues where it is 5 years after sale or write off. Our firm commenced scanning all the documents that came through the office (including year end work files) from January 2006 which means the time has lapsed for retaining all paper documents. Those in that situation have been contacted to be given the option as to whether they wish for their files to be shredded or if they want to collect them from the office.

#### Will your firm's HR infrastructure & governance stand up against a complaint?

Sometimes things don't always go to plan. Firms occasionally get sued for a variety of reasons including, sexual harassment, bullying and unfair dismissal. We have seen recent evidence of this in the very public David Jones case. The leadership team traditionally would set the example of the firms' culture and should recruit only in accordance with those values. That way, should you have a behavioral breach with an employee, you can respond accordingly. The best way to articulate this culture is via your business plan and employment contracts, not only as goals but as fundamental metrics of the business performance. All contracts, policies and procedures are based upon these values and directed towards best behaviors and can also be used as a threshold KPI for the business owner.

#### Check economies of scale on your farm

The *feedbudget and rotation planner calculator* assists with planning rotational grazing systems, determining appropriate stocking rates, calculating pasture growth rates, determining paddock longevity and calculating the most economical ration for livestock.

The *pasture improvement calculator* helps to determine the costs and benefits of resowing pastures. You can input the costs of resowing/resown pastures to livestock, soils and the environment at varied financial values. Comparisons can then be made between two different options against current practice.

#### \$550 reduction in taxable income for Youth Allowance recipients

Following the High Court decision in the Anstis case, the ATO will amend tax assessments of eligible tax payers to include \$550 tax deduction for education expenses for each of the 2007, 2008, 2009 and 2010 income years. Former student Symone Anstis successfully challenged the Commissioner of Taxation, claiming certain education expenses as allowable deductions against her Youth Allowance. Eligible taxpayers will receive a letter from the ATO between 1 March - 30 April 2011 advising that an amended tax assessment will be sent to them. Assuming a full time student is in the 15% tax bracket, the \$550 reduction in taxable income equates to an \$82.50 refund.
