### Cash Economy targeted by ATO ...

The ATO is sending out over 110,000 letters to taxpayers suspected of being involved in the cash economy. Having proper record keeping programs protects the small businesses owner from ATO scrutiny and assists with daily decision making. To assist you regarding this we have BankLink. ### Still waiting on your refund cheque?

The ATO has undergone major upgrade to its IT system in an effort to help identify fraudulent and overstated claims. This implementation is causing delays in processing tax returns, so clients who are expecting a tax refund from the ATO may need to wait for another one or two weeks for their tax refund to arrive.

# If you have less than \$2 million turnover you could get an extension of GIC-free payment arrangements

General Interest Charge (GIC) free payment arrangements have been extended until 30 June 2011. Small businesses with a turnover of less than \$2 million who have activity statement debts can apply for a GIC-free payment arrangement for a maximum of 12 months period. Activity statement debts include GST and PAYG. This arrangement is only available with a direct debit payment method. If payment arrangement is defaulted on, the GIC-free period will end on the date of default. Please contact us if you would like to take advantage of this concession.

### Look out if you are selling art or jewellery for New Royalty payments

With the introduction of *Resale Royalty Right for Visual Artists Act 2009*, a 5% royalty applies to the commercial resale of artworks valued over \$1,000 starting from the second change of ownership commencing 9 June 2010. This does not apply to private sales without an art professional involved. Copyright Agency Limited has been appointed by the government to collect and distribute royalty fund. The art professional is the person expected to collect the royalty but the purchaser, vendor and agent are all joint and severally liable.
